1. **Coursework:** I've an Associate of Science and a Bachelor's degree. I've also completed additional coursework. Postliminary training includes a University of Waikato (UoW) IPC (<u>COUNS546</u>, UoW Counselling Faculty, 2019) and clinical specialist training in counselling at the Association of Sex Addicts Trauma Specialists (<u>APSATS</u>, 2022).
